Why do I need estate planning?

You won't leave (as much of) a mess for your family!

You get to direct what happens, not state intestacy law

You can take care of issues your family faces in an informed way

- Funeral planning
- Children
- Heirs with disabilities, other issues of concern
- Heirlooms

You can make charitable gifts if you plan them – your heirs or the state cannot

What do I need to do to get ready?

Write up an inventory of your property, answering four questions:

- 1. What do you own? (real estate, business property, bank and investment accounts, life insurance, cars, boats, "tangible personal property", trusts
- 2. How much is it worth?
- 3. How do you own it? (sole ownership, joint ownership, custody)
- 4. Does it have its own beneficiary? (life insurance, pension and retirement plans, IRAs, accounts with "payable on death" designation)

Think about who should get what, when, and how much?

Probate

- Proving the will is the last legitimate will
- Formally accepting the will
- · Appointing an executor

Administering the estate

- Gathering the assets and getting them under control (such as the following, if needed: open estate checking and brokerage accounts, changing locks, collecting and safeguarding valuables)
- Valuing the assets (date of death values, income accrued to the date of death, appraisals)
- Identify and pay decedent's bills and last expenses
- File an Inventory document with Register of Wills
- Pennsylvania Inheritance Tax payments and return
- Account to the beneficiaries
- Deliver property to the beneficiaries
- Close the estate
